## Description

Sika<sup>®</sup> Aktivator UH-2 LUM is a moisture-sensitive, activating agent designed to improve adhesion. It is specifically formulated for the treatment of bond faces prior to the application of various Sikaflex<sup>®</sup> and SikaTack<sup>®</sup> polyurethane adhesives. Sika<sup>®</sup> Aktivator UH-2 LUM does fluoresce under long-wave UV light.

Sika<sup>®</sup> Aktivator UH-2 LUM is manufactured in accordance with ISO 9001 / 14001 quality assurance system and the responsible care program.

## **Areas of Application**

Sika<sup>®</sup> Aktivator UH-2 LUM improves adhesion on substrates such as glass, ceramic coated glass, and paints.

Note: Sika<sup>®</sup> Aktivator UH-2 LUM is not a substitute for Sika<sup>®</sup> Aktivator

This product is suitable for experienced professional users only. Tests with actual substrates and conditions have to be performed to ensure adhesion and material compatibility.

## **Method of Application**

Wipe bond faces with a clean, lint-free paper towel moistened with Sika® Aktivator UH-2 LUM. Apply Sika® Aktivator UH-2 LUM sparingly, and apply once only. Immediately wipe-off any excess with a clean, dry, lint-free paper towel.

Consumption depends on the specific nature of the substrates and manufacturing process.

Tightly re-seal container immediately after each use.

#### **Important Note**

Sika<sup>®</sup> Aktivator UH-2 LUM contains solvent which may dull the surface finish of some freshly applied paints. Preliminary trials must be carried out. Never apply to porous substrates. Sika<sup>®</sup> Aktivator UH-2 LUM may not dry completely on porous surfaces preventing the adhesive or sealant from curing properly. Protect adjacent surfaces by masking where necessary.

Sika<sup>®</sup> Aktivator UH-2 LUM is a moisture reactive system. In order to maintain product quality it is important to reseal the container with the inner plastic liner immediately after use. Once the surface pretreatment operation is completed the cap has to be screwed on. Prolonged exposure to atmospheric moisture will cause Sika<sup>®</sup> Aktivator UH-2 LUM to become inactive. Immediately discard Sika<sup>®</sup> Aktivator UH-2 LUM if it has become cloudy or opaque, instead of transparent.

Dispose the product one month after opening the bottle for the first time or at the end of the marked expiration date; whichever comes first.

Never dilute or mix Sika<sup>®</sup> Aktivator UH-2 LUM with any other substances. It is not to be used for tooling / smoothing of products and as a bare cleaning agent.

## **Detection of the luminescence**

Sika<sup>®</sup> Aktivator UH-2 LUM can be visualized by using a light source with a wavelength of 320 to 420 nm as in-line control. By reducing foreign light such as sunlight or artificial light during the detecting process the quality of the detection can be increased significantly.

Note: The luminescent effect will degrade with time.

#### Limitations

- Do not apply on frozen surfaces or through standing water.
- Do not apply over silicones or in the presence of curing silicones.
