Center the Sarnadisc® RhinoBond plate over the RhinoBond® PS Cardboard Disc so the center holes are aligned. Insert the Sikaplan® fastener through the center holes and fastened to the approved roof deck, clamping the fanfold roofing underlayment in place.
