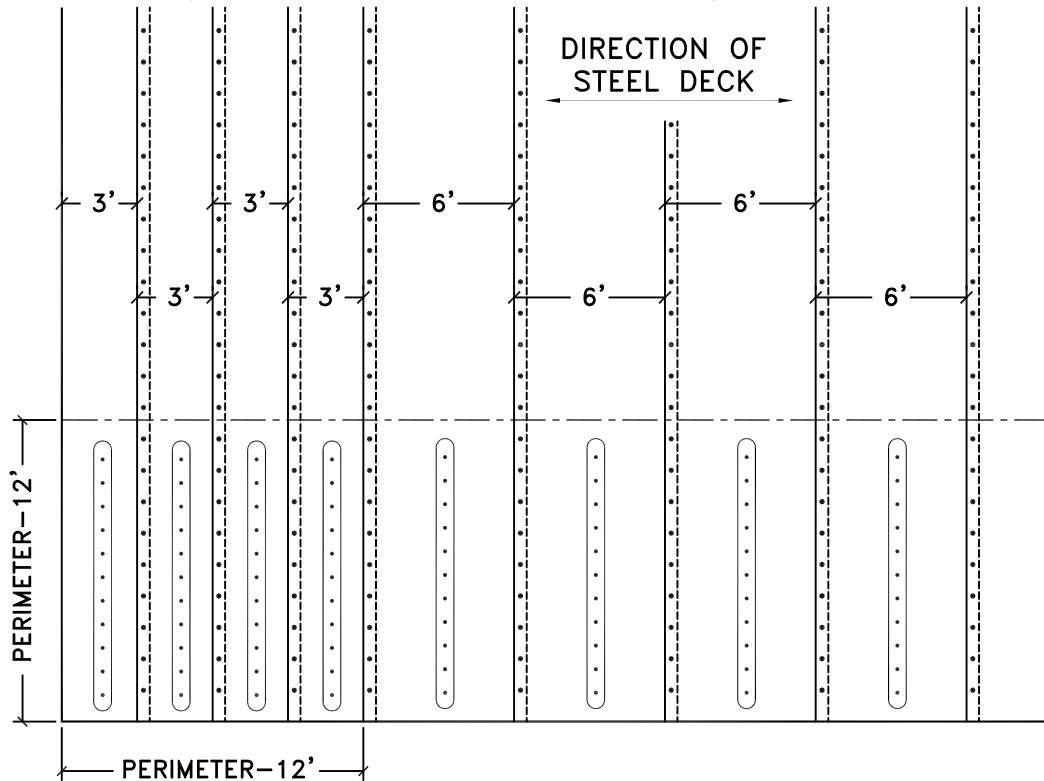


**ALTERNATE CORNER LAYOUT FOR 6 FT. SHEET
