After the curb or wall flashings are installed, Sarnacorners - Outside are heat welded in place with a hand-held hot-air welder and roller. No caulking or sealants are necessary.

### MAINTENANCE

Standard maintenance of roofs should include regular inspection of flashings, drains and termination sealants at least twice a year and after each storm.
