Subject: Environmental Product Declaration (EPDs) for Sikalastic -641, -644 and LEED V4 Information

SS Credit: Heat Island Reduction - High-Reflectance Roof (~1 point)

Use roofing materials that have an SRI equal to orgreater than the values in Table 1. Meet the three-year aged SRI value. If three-year aged value information is not available, use [...] the initial SRI value.

Table 1. Minimum solar reflectance index value, by roof slope

	Slope	Initial SRI	3-year aged SRI
Low-sloped roof	≤ 2:12	82	64
Steep-sloped roof	> 2:12	39	32

- Sika Fleece 120, 140, 170: 98% recycled content

Exterior applied products [...] must meet the VOC limits of California Air Resources Board (CARB) 2007 Suggested Control Measure (SCM) for Architectural Coatings, and South Coast Air Quality Management District (SCAQMD), Rule 1168, effective July 1, 2005.

Sikalastic-641 Lo-VOC: ≤ 38 g/l
 Sikalastic-644 Lo-VOC: ≤ 15 g/l
