









TYPICAL WINDOW HEAD (RECESSED)









TYPICAL WINDOW SILL (FLUSH)













TYPICAL EXPANSION JOINT AT FLOOR LINE











TYPICAL PIPE PENETRATION





TYPICAL CORNER MESH APPLICATION WITH STRONG 15 OR ULTRA HI 20













TYPICAL CHANNELED INSULATION BOARD PROFILE




