SYSTEM INFORMATION

INSTALLATION

Sarnastack Universal's base flange is heat welded in place with a hand-held hot-air welder and roller. Apply a bead of Sikaflex®- 1a sealant at the top of the Sarnastack Universal between the penetration and the boot. Install the stainless steel clamping ring at the top of the Sarnastack Universal creating a seal by compressing the Sikaflex-1a between the penetration and the boot.

AVAILABILITY

From Sika Corporation – Roofing Authorized Applications for use within Sarnafil or Sikaplan systems.

MAINTENANCE

Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
