Sarnadisc GypTec is positioned on the surface of 5 ft (1.5

m) Sarnafil S 327 or Sikaplan Fastened membrane and a Fastener GypTec screw is placed through the center of it and then set into the approved roof deck, clamping the membrane in place.

MAINTENANCE

Standard maintenance of Sarnafil® or Sikaplan® systems should include regular inspection of flashings, drains and termination sealants at least twice a year and after each storm.
