In its mixed, uncured state, SikaBiresin® AP111 has a smooth, creamy consistency that enables the user to make quick repairs with minimal air entrapment.

AREAS OF APPLICATION

SikaBiresin® AP111 is suitable for filling, bonding, and repair applications in a wide range of industries. Typical applications include boat decks to hulls, FRP-to-FRP, fiberglass-to-metal, metal-to-concrete, detail blocks to FRP, fiber auto panels, wood-to-wood, metal-to-metal and concrete-to-concrete.

PROCESSING

Surface Preparation and Application

To ensure optimal adhesion, the area to be filled or repaired should be thoroughly cleaned, sanded/roughened, re-cleaned, and allowed to dry prior to application.

Mixing Instructions

Stir contents of resin can thoroughly using a spatula or putty knife. Place the required amount of filler and cream hardener on a disposable clean surface. Mix 100 parts paste to 2 parts cream hardener by weight. Set up time of mix at room temperature will be 10-20 minutes

Application

The mixed SikaBiresin® AP111 should be applied and worked into the area, taking caution to avoid air entrapment. After curing to a tack-free state, the material can be sanded and finished as needed.

18 months when stored in original unopened containers between 65 – 77°F (15 – 25°C). Keep containers tightly closed. Polyester resin contains filler which has the potential to separate in time, please re-homogenize prior to use.
