## Description

Sikafloor Marine 120 is a one component light weight and self-leveling mortar based on polymer modified cement.

Sikafloor Marine 120 is manufactured in accordance with ISO 9001 / 14001 quality assurance and tested according to FTP Code system and approved according to the IMO Marine Equipment Directives.

## **Areas of Application**

Sikafloor Marine 120 is applied on interior decks, to level the surface prior to the application of deck finishing materials such as: carpets, tiles, parquet, rubber and vinyl. It is suitable for application in dry and wet accommodation areas.

#### Cure Mechanism

Sikafloor® Marine 120 cures by way of hydraulic curing.

## **Method of Application**

Surface preparation

The surface has to be clean, free from dust, grease, oils and other substances, which may impair the adhesion. Rust has to be removed with a steel brush or other appropriate means, followed by a vacuum cleaning.

The surface has to be primed with Sikafloor® Marine Primer-C using a long hair roller. After the drying of the primer, Sikafloor Marine 120 may be applied.

120 For Sikafloor Marine applications on aluminum or decks coated with a zinc rich shop primer, a tie coat of SikaCor® ZP Primer or another suitable tie coat is required prior to priming step with Sikafloor Marine Primer-C.

## Mixing process

One bag Sikafloor Marine 120 is mixed with 5.9 to 6.6 liters (200 to 220 oz) of cold, potable water. The mixing time is approx. 3 minutes at low speed until a homogenous mortar is obtained. If mixed by hand, ensure the powder is mixed completely (bottom and side walls of the bucket).

## **Application**

Apply the mortar with a steel board or a straight edge.

Sikafloor Marine 120 has to be applied within 30 minutes after mixing. At temperatures above 35° C (95° F), the open time will be reduced to 20 minutes or less.

#### Curing

After application, the finished areas should be protected against direct heat, sunlight and draught during the curing process for at least one day after application.

Before covering Sikafloor Marine 120 with dense materials such as vinyl, epoxy coatings etc., ensure that the remaining moisture level is below 4%. Test procedure to determine the dryness (according ASTM D 4263)

- put a PE-plastic foil 1 m x 1 m (40 in x 40 in) on the surface of the applied mortar floor
- tape the perimeter and leave for one day

The curing is complete if there is no water condensation on the foil or a visible color difference between covered and uncovered surface.

#### Removal

Excess material can best be removed before curing with a trowel wipe. Uncured Sikafloor Marine 120 may removed from tools be equipment with water. Once cured, the material can only be removed mechanically. Exposed hands and skin should be washed immediately with water. Use a suitable skin protection hand cream.

## **Application limits**

Do not apply Sikafloor Marine 120 on sloping surfaces (>3%). For applications on sloping surfaces above 3%, contact the Technical Service Department of Sika Industry.
