LIMITATIONS

• The minimum ambient and surface temperatures

- should be 32°F (0°C) and rising. Curing time will be longer at lower temperatures.
- When the ambient temperature is below 50°F (10°C), warm the material to a temperature of 70°F (24°C) at the time of application.
- For use on low slope surfaces (<3%, 3/8" per ft).

SUBSTRATE PREPARATION

Surfaces should be clean, dry, free of dirt, dust, debris, oils and other contaminants.

Prime glass-mat roof boards with Vapor Retarder Primer TA prior to the application of Vapor Retarder Adhesive CA SB. Priming is optional when using coated glass-mat roof boards.

Apply Vapor Retarder Adhesive CA SB with a 1/4" (4.8) mm) notched neoprene squeegee or trowel.

MAINTENANCE

Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
