Sika® Fibermesh® FN is a monofilament nylon microfiber for use as secondary reinforcement in concrete. Manufactured from 100% virgin nylon (polyamides). Sika® Fibermesh® FN is designed to control plastic shrinkage and settlement cracking as secondary concrete reinforcement.

USES

Sika® Fibermesh® FN act mechanically by supporting the aggregate within the concrete with multidimensional fiber network and developing a uniform bleed system. Sika® Fibermesh® FN can retain approximentally 4-5% of their weight in water, slowing bleed water, aiding in hydration and reducing crazing cracking. Typical applications include:

- Slabs on ground
- Architectural concrete
- Precast elements
- Stucco
