### APPLICATION INSTRUCTIONS

#### APPLICATION

Control Test Drain openings shall be laid out and installed according to accepted plans and specifications. Install control opening by drilling a 13/16" (21mm) diameter hole through the substrate. Install pipe with

neoprene seal level with the surface of the substrate. The stainless steel plate shall be mechanically fastened to the substrate and sealed completely with grid adhesive. Install connecting flange and collection vessel.

## MAINTENANCE

Standard maintenance of Sarnafil® or Sikaplan® systems should include regular inspection of flashings, drains and termination sealants at least twice a year and after each storm.
