SURFACE PREPARATION

- Concrete substrates must be sound and of sufficient compressive strength (minimum 25 N/mm2) with a minimum pull off strength of 1.5 N/mm2.
- The substrate must be clean, dry and free of all contaminants such as dirt, oil, grease, coatings and surface treatments, etc.
- On critical substrates, e.g a strong absorbent

Product Data Sheet Sikafloor®-7500 November 2018, Version 01.02 02081103002000008 cementitious surface, the application of a trial area is highly recommended, in order to ensure a pore free surface, after priming.

- Concrete substrates must be prepared mechanically using abrasive blast cleaning or scarifying equipment to remove cement laitance and achieve an open textured surface.
- Weak concrete must be removed and surface defects such as blowholes and voids must be fully exposed.

- Repairs to the substrate, filling of blowholes/voids and surface levelling must be carried out using appropriate products from the Sikafloor[®], Sikadur[®] and Sikagard[®] range of materials.
- The concrete or screed substrate has to be primed or levelled in order to achieve an even surface.
- High spots must be removed by e.g. grinding.
- All dust, loose and friable material must be completely removed from all surfaces before application of the product, preferably by brush and/or vacuum.

MIXING

Prior to mixing, stir part A mechanically. When all of part B has been added to part A, mix continuously for 2 minutes until a uniform mix has been achieved. To ensure thorough mixing pour materials into another container and mix again to achieve a consistent mix. Over mixing must be avoided to minimise air entrainment.

Mixing Tools:

Sikafloor[®]-7500 must be thoroughly mixed using a low speed electric stirrer (300 - 400 rpm) or other suitable equipment.

APPLICATION

Prior to application, confirm substrate moisture content, relative humidity and dew point.

If > 4% pbw moisture content, Sikafloor[®] EpoCem[®] may be applied as a temporary moisture barrier (T.M.B.) system.

Sikafloor[®]-7500 is spread evenly using a roller. A seamless finish can be achieved if a "wet" edge is maintained during application.

CLEANING OF TOOLS

Clean all tools and application equipment with Thinner C immediately after use. Hardened and/or cured material can only be removed mechanically.

BASIS OF PRODUCT DATA

Results may differ based upon statistical variations depending upon mixing methods and equipment, temperature, application methods, test methods, actual site conditions and curing conditions.
