APPLICATION

Unroll and position Crossgrip XTRA within the specified areas and cut to desired length. Do not install Crossgrip XTRA directly over Sarnabars. Crossgrip XTRA is installed loose-laid on top of completed Sarnafil and Sikaplan roof assemblies.

COVERAGE

Approximately 99 ft² per roll (9.2 m²).

MAINTENANCE

Standard maintenance of Sarnafil and Sikaplan systems should include regular inspections of flashings, drains, and termination sealants at least twice a year and after each storm.
