Sarnabars SS is normally mechanically attached through the waterproofing membrane as close to the base of the walls, curbs, transitions and penetrations as possible. The Sarnabar and fasteners effectively clamp the membrane to the substrate or the structural deck.

### MAINTENANCE

Standard maintenance of roofs should include regular inspection of flashings, drains and termination sealants at least twice a year and after each storm.
