

## Non-Catalyzed versus Catalyzed Grouts MasterFlow<sup>®</sup> 885

Master Builders Solutions offers a high performance, nonshrink grout that contains metallic aggregate called MasterFlow 885. This grout should not be confused with older generation grout products that contained metallic particles or powder often referred to as "Catalyzed" metallic grouts which utilized oxidation of the metal after the grout had hardened to compensate for shrinkage. MasterFlow 885 utilizes metal only in the form of aggregate that does not oxidize to compensate for shrinkage. MasterFlow 885 is a "Non-Catalyzed" grout and therefore is not subject to the uncontrolled expansion typical of catalyzed grouts. A precision nonshrink grout, MasterFlow 885 meets the performance requirements of ASTM C 1107 and CRD-C 621, Grades B and C.
