Sarnatherm<sup>®</sup> Roof Board H may be installed by mechanical attachment to the roof deck with approved fasteners and insulation plates or by attachment with Sarnacol board adhesive depending on project requirements and specifications. Roof boards that have become wet or damaged should be removed and replaced with solid, dry roof boards. Contact Sika Corporation – Roofing Technical Department regarding alternative methods of attachment.

### MAINTENANCE

Standard maintenance of Sarnafil or Sikaplan systems should include regular inspections of flashings, drains,

and termination sealants at least twice a year and after each storm.
