APPLICATION METHOD / TOOLS

Sikagard-375 Mat - Roll

Sikagard-375 Mat may be slightly curled on the ends when first unrolled. If this occurs, allow the mat to lay flat and relax. Roll the matting out a few hours prior to the installation. A utility knife can be used to carefully cut Sikagard-375 Mat. To avoid any frayed edges, it may be necessary to score the material, cut twice, before pulling the two pieces apart. Hold the knife at a 90° angle to ensure a clean straight edge. Sikagard-375 Mat can be left loose as runners for applications such as pool decks, locker rooms, restrooms, or shower areas. It may also be secured to a surface with the use of a specialty adhesive or screws if necessary.

Cleaning

Sikagard-375 Mat does not require any maintenance. Proper surface preparation and installation ensure a maintenance-free area. Dirt and debris may be flushed from the pad or roll by using a power spray or water hose.
