SIKAPLAN® TERMINATION BAR

Sikaplan Termination Bar is an extruded aluminum termination bar with a mill finish used to terminate Sikaplan roofing membranes at walls and roof edges. It is 3/4 in (19 mm) wide, 0.090 in (2.3 mm) thick and has a 3/16 in (4.8 mm) lip formed at a 45° angle. Each termination bar is 10 ft (3.05 m) long with oval holes punched 6 in (152 mm) on center.

Install Sikaplan Termination Bar with a ¼ in (6 mm) gap between adjoining bars. Cut Sikaplan Termination Bar at inside and outside corners. Do not bend around corners. Fasten Sikaplan Termination Bar with approved fasteners 12 in (305 mm) on center and within 1 in (25 mm) of each bar end. Refer to specific Sikaplan detail drawings.

10 linear feet (3.05 m) per bar
