Dear Alec,

The flowing are the guidelines for the major use of Sikaflex®-2c NS EZ Mix and Sikaflex®-2c NS Arctic.

For both the School Classroom and the Private Office, Sikaflex $^{\circ}$ -2c NS EZ Mix and Sikaflex $^{\circ}$ -2c NS Arctic would be predominantly applied as a perimeter seal for windows. The average bead size would be $\frac{1}{2}$ inch wide by $\frac{1}{4}$ inch deep.
