## SARNAREGLET

Sarnareglet is a heavy-duty counterflashing used as a key component within certain flashing details for Sika Sarnafil roofing and waterproofing systems.

#### COMPOSITION

Sarnareglet is produced from 6063T5 extruded aluminum and is provided with predrilled holes at 8 in (20 cm) o.c. for attachment to walls or curbs. The holes are symmetrically offset from the ends of the Sarnareglet and are slotted to allow for thermal expansion and contraction.

#### DIMENSIONS

Thickness: 0.10-0.12 in (2.5-3.0 mm)

Length: 10 ft (3.05 m) length

<b>INSTALLATION</b>	A passive sealant bed is first applied to the wall or high curb according to Sika Sarnafil's Detail Drawings. The membrane flashing or the Sarnaclad flashing is then installed. The Sarnareglet is positioned, leveled and fastened to the wall or curb against the top of the flashing to securely clamp the flashing in place. The primary (active) sealant is then applied onto the Sarnareglet sealant shelf and rolled/feathered according the sealant manufacturer's recommendations or requirements.
<b>AVAILABILITY</b>	From Sika Corporation – Roofing Authorized Applications for use within Sarnafil or Sikaplan systems.
<b>MAINTENANCE</b>	Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
<b>WARRANTY</b>	As a Sika supplied accessory, Sarnareglet is covered under Sika Corporation warranties.
