SYSTEM INFORMATION

INSTALLATION	Sarnaclad - SS is cut to size and formed to shape on standard sheet metal equipment. Sarnaclad - SS is fastened in position in accordance with Sika Sarnafil Technical requirements. The Sarnaclad - SS joints are covered by 2 in (51 mm) wide aluminum foil tape and then made watertight by heat-welding a 4 in (102 mm) wide G410 membrane strip over the tape. By use of a Sarnafil G or S coverstrip, the roofing or waterproofing membrane is then heat-welded to the Sarnaclad - SS.
AVAILABILITY	From Sika Corporation – Roofing Authorized Applications for use within Sarnafil or Sikaplan systems.
MAINTENANCE	Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
