Dear Valued Sika Customer:

With the implementation of LEED v4 and the sunset of LEED 2009 there have been a lot of questions concerning the areas where Sika products can achieve points towards LEED v4 Credits. The following information is being supplied to answer these basic questions.

There are currently three areas that Sika has evaluated where Sika products can achieve LEED v4 points. These are:

1. Environmental Credit – EQ5 – Low Emitting Materials
2. Material Credit – MR 2 – Environmental Product Declaration – Option 1
3. Material Credit – MR4 – Material Ingredients – Option 1

To date, Sika's focus has been on Environmental Credit – EQ5 – Low Emitting Materials. The following products have been tested and meet the requirements of this credit:
